# Apply for Unemployment Compensation!

Unemployment compensation can put cash in your pocket when you have lost your job through no fault of your own.

**If you are out of work or are losing hours because of the current public health crisis, you may qualify for Pennsylvania Unemployment Compensation.**

Have your **hours been reduced** because of the Coronavirus or its impact?

Have you been **temporarily laid off** or has your workplace closed?

Were you **sent home** due to minor symptoms?

Do you need to **care for a family member**?

Were you fired when you **refused to work in unsafe conditions**?

Did you quit to **avoid unsafe conditions**?

Please note it may be difficult to reach UC by telephone during high volume times.

After you apply for unemployment, every two weeks you must **file a claim** at [www.us.pa.gov](http://www.us.pa.gov) or by calling **1-888-255-4728** and

- Report any hours you worked
- Report any PTO you received
- Report any pay you received
