# Pandemic Forces Legal Aid to Think Outside the Box

Neighborhood Legal Services' attorney Meghan Tighe took her role as a lawyer to a new level once COVID-19 put a halt on most legal actions. Her client Candace was experiencing a difficult situation with her landlord when he changed the locks on her apartment before she was able to completely move out. Although Candace was already in the process of moving somewhere else, belongings like her child's clothes were left behind in the locked apartment. In normal circumstances, an attorney would file an injunction ordering the landlord to allow the tenant back into the property to retrieve their belongings. However, in times like these, attorneys need to think on their feet in hopes of settling these issues outside of court. The landlord believed that he had won the argument and case against the tenant who had not been paying rent. Until Tighe explained that there was still a hearing to come on the matter, he believed he was in the right. She negotiated an agreement with the landlord where she would accompany Candace to the apartment, since he demanded a constable be present, which could not happen at this time, to make sure that the she could safely retrieve her belongings.

In this situation, I had to scramble and do something different to still try and help outside of normal circumstances [and things] that we normally do. With the courts being arguably closed, I had to intervene myself to settle this issue as quickly and easily as possible, <sup>59</sup> said Tighe.

Once she was able to arrange a time for everyone to meet, Tighe made sure Candace was able to get in and monitored the situation to ensure everything went smoothly. Tighe successfully helped another NLS client by going above and beyond to safeguard Candace and her child.





### **NLS Launches New Website**

With the official launch of Neighborhood Legal Services' new website, visitors can move through the site more easily than ever before to find information, apply for legal aid and get the help they need.

The re-designed website features a new Legal Wellness Check Up tool. The Legal Wellness Check Up provides users the opportunity to assess their legal health by identifying possible areas of legal risk such as housing instability, consumer debt or family matters, and provides referral information about community resources to help avoid a potential legal crisis. Once visitors click on the Legal Wellness Check Up tool they are asked a series of simple questions where they click on an appropriate answer and based on their responses, the Legal Wellness Check Up tool will direct them to help through NLS or refer them to other community resources. "This is an exceptional new feature to our website, not only because it helps people identify their areas of potential legal risk but also what needs to be done to mitigate those risks. That feature can be incredibly helpful to someone who is in danger of losing their home, or benefits, or is having issues with a spouse or partner," explained Dana Crawford, a Public Ally who worked with legal aid staff to launch the new website and Legal Wellness Check Up tool.

If NLS is unable to help, the Legal Wellness Check Up will refer them to other resources such as a domestic abuse hotline number, housing discrimination help or a lawyer referral service. "If NLS can't help, we want to make sure people aren't turned away and can find other resources they need," added Crawford.

While most county court systems moved to video and teleconferencing, others are still requiring in person hearings. The efforts of those attorneys who have had to attend those in-person court dates speak to the dedication they have for their work and clients.

So, at some point, the question will be what's next? As shelter-at-home orders ease and we gradually see a return to "normal" life, we anticipate a big increase in demand for services, particularly as more middle-class Pennsylvanians will now suddenly be eligible for free legal assistance to help address emerging issues. All legal aid programs in Pennsylvania have already been informed that the fiscal year allocation beginning July 1 will be reduced. Unfortunately, this will occur just at the time we expect to see more client demand.

In this newsletter, we'll share news about how our hard-working staff attorneys, administrators and volunteers have dedicated themselves to helping clients in this challenging time. ### Susan Abramowich Managing Attorney, Family Law Helping Families Navigate Lives During the Pandemic

As managing attorney for family law at Neighborhood Legal Services, Susan Abramowich oversees all family law attorneys and services at NLS offices. She works closely with family law and Victims of Crime Act (VOCA) attorneys in Allegheny, Beaver, Butler and Lawrence counties to coordinate services and create a cohesive approach to how NLS works with clients to deliver services. As Abramowich explained, prior to her appointment, there was no managing attorney role in family law, "But it was important to have all our offices work together for advice, best practices and access to resources." This unified approach has never been more important than during the pandemic when in-person meetings have for the most part been eliminated and replaced with Zoom or Skype meetings.

We recently spoke to Abramowich about how the pandemic has impacted the family law services at NLS and her thoughts on the challenges ahead.

### What are some of the biggest challenges to delivering services to families during the pandemic?

The biggest challenges are practical, for example, meeting with clients, helping them to access services, understanding that they are dealing with income, transportation, and childcare challenges. But when you add in all these concrete challenges to families (whether intact or separate) who are already under stress, the situation becomes explosive, exacerbated, or desperate. Suddenly, cases that have been relatively "status quo" are bickering and going back and forth about custody exchanges and if appropriate precautions are being exercised.

#### Were you prepared for the challenges and if so, how?

Luckily, we had warnings from jurisdictions impacted by the pandemic before we were. We expected an increase in domestic violence and a likely decrease in filings and this has

indeed been the case, not only here in the Pittsburgh region, but nationally, even globally as well. The custody questions were less anticipated since so much focus is placed upon domestic abuse (including child and animal abuse which also likely increase during this time). Most surprises have been positive.... the court administration responded quickly, the staff adapted efficiently, meetings and dialogue among local practitioners and judges increased, information shared on state and local level has been prolific and helpful.

### Are the challenges for delivering services different by counties?

Allegheny County is ahead of the pack in many ways. The President Judge quickly responded and moved all operations remote, utilizing advanced communication technology when necessary. The county already had many technological advances including an online Department of Court Records, e-filing, and audiovisual equipment. Some outer, more rural counties do not have online court documents and the technical equipment necessary to respond as quickly. However, many of our attorneys are taking advantage of such tools as Legal Server that allow for electronic document signing, lessening the need for in-person meetings. And like almost all industries, we are all experts in Zoom meetings now as the courts, the bar and professional organizations have moved to virtual formats. And of course, oldfashioned phone calls are making a comeback.
